### Investment objective

The fund aims to outperform the S&P/ASX300 Accumulation Index over a rolling three year period.

### Investment strategy

The Australian Masters Equity Fund is designed to provide investors with access to some of Australia's top fund managers that are normally only accessible to high net worth investors.

The current five underlying funds all have distinctively different methods of investing, providing exposure to the entire breadth of the market. They are highly transparent, 'long only' investors. The size of their individual funds allows them to remain nimble enough to trade quickly as market conditions change, and helps eliminate the possibility that they become index funds.

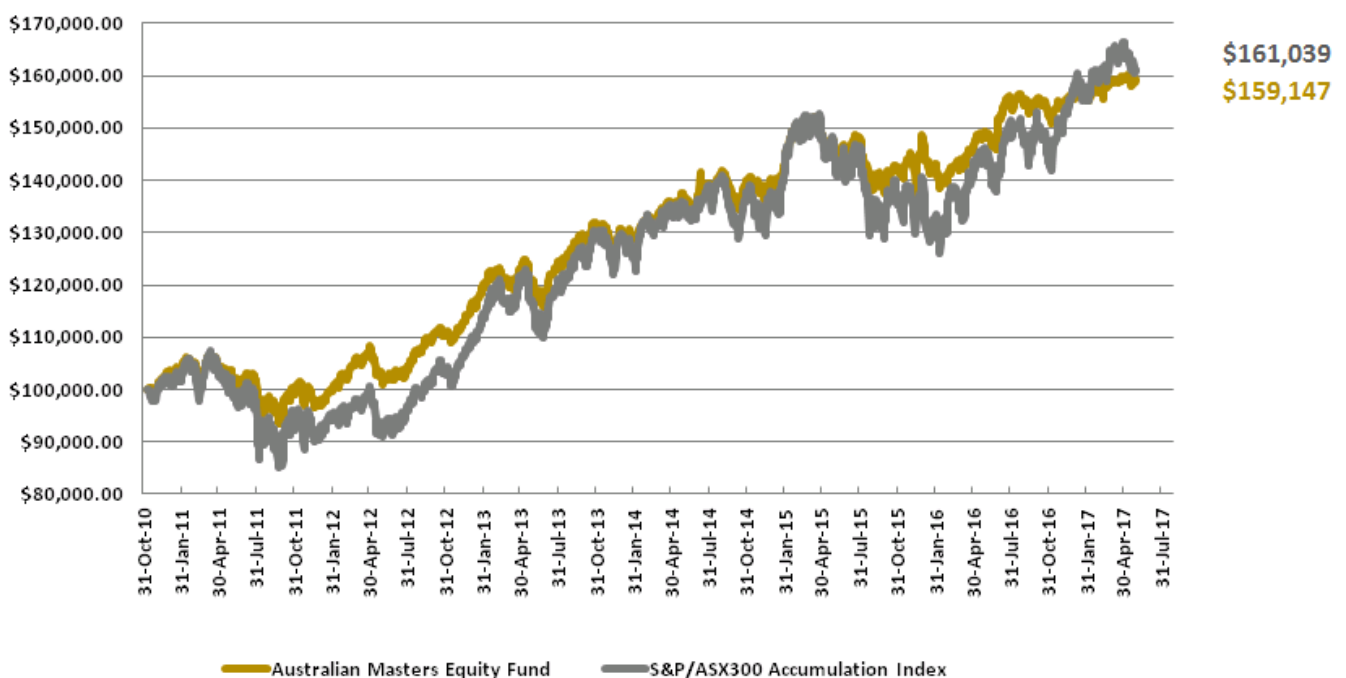

**Airlie Concentrated Share Fund** returned -2.50% in the month of May, outperforming the S&P/ASX 300 accumulation index, which returned -2.74%. Since inception the Fund has returned 60.19%, compared to the S&P/ASX 300 accumulation index which has returned 54.51% over the same period. The portfolio remains cautiously positioned, with the cash weighting in the portfolio at approximately 29.86%. The top five active positions in the portfolio are Nick Scali Ltd, Caltex Australia Ltd, Elanor Investors Group, Gowing Bros Ltd, and Macquarie Group Ltd.



**Cooper Investors Brunswick Fund** returned 5.39% for the rolling 3 month period ending 31 May 2017, outperforming the S&P/ASX 200 Accumulation Index, which returned 1.52% for the same period. Key holdings in the portfolio at the end of May 2017 were ALE Property Group, Aurizon Holdings Ltd, ASX Ltd, Washington H Soul Pattinson, and Ryman Healthcare. Since inception the Fund has returned 661.51%, compared to the 186.67% returned by the S&P/ASX 200 Index over the same period.



**Greencape Wholesale Broadcap Fund** returned -2.84% for the month of May, underperforming the S&P/ASX 300 Accumulation Index which returned -2.74%. Key contributors to the portfolio performance were EML Payments Ltd, a2 Milk Co Ltd and Fisher & Paykel Healthcare Corp Ltd. Key detractors to the portfolio performance were James Hardie Industries PLC, Vocus Group Ltd and Telstra Corp Ltd.



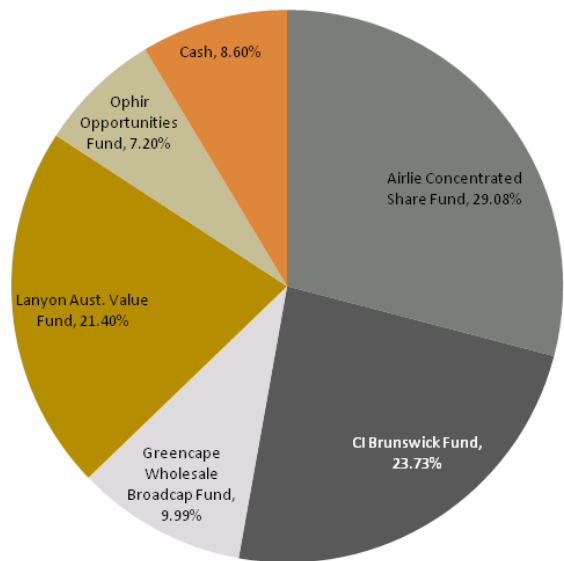
**Lanyon Australian Value Fund** increased by 0.4% during the month of May, outperforming the All Ordinaries Accumulation Index which returned -2.6%. Since inception the Fund has returned 173.9%, compared to the 80.0% returned by the All Ordinaries Accumulation Index over the same period.



**Ophir Opportunities Fund** increased 2.6% during the month of May, outperforming the S&P/ASX Small Ordinaries Accumulation Index which fell 2.0%. Key contributors to the portfolio performance included Netcomm Wireless, RCR Tomlinson and Melbourne IT. Key detractors included Sundance Energy, Mount Gibson Iron and Monash IVF. Since inception the Fund has returned 337.5%, compared to the 29.1% returned by the S&P/ASX Small Ordinaries Accumulation Index.
